

Procedures for Tender Offer Acceptance of Abico Holdings Public Company Limited and Share Subscription of Malee Group Public Company Limited



Share certificate holders submit the Form for Tender Offer Acceptance and Share Subscription together with supporting documents within 7 December 2022 or at least 2 business days prior to the last day of the Tender Offer Period

In case of shares deposited with TSD under the Issuer Account number 600, complete the form "Request for Securities transfer to/from issuer account with participant" ("Form TSD-403") in Enclosure 11 and attach a set of identification documents of the securities holders in accordance with the type of person as specified on page 2 of the form, in addition to the Tender Offer Acceptance Form and the supporting documents, within 7 December 2022 or at least 2 business days prior to the last day of the Tender Offer Period

In case that the prefix name, the name, or the surname of the Offeree shown on the share certificate is different from the prefix name, the name, or the surname of the Offeree shown on the ID Card, Civil Servant ID Card, State Enterprise Employee Card, alien certificate, or passport, or in case the name of juristic person shown on the share certificate is different from the Affidavit, issued by the Ministry of Commerce, certificate of incorporation, or memorandum of association (for juristic person), the Offeree shall complete the form "Amending Securities Holder Records" of the Thailand Securities Depository Company Limited ("TSD") ("Form TSD-301") in Enclosure 10 and shall attach the evidence of amendment issued by the government authority with certified true copy. The name that has been changed must match with the name shown on the ID Card, Civil Servant ID Card, or State Enterprise Employee Card, passport, Affidavit, or certificate of incorporation, as the case may be.

In case the Offeree is a juristic person not conducting business in Thailand and domiciled in a country which does not have a double taxation treaty with Thailand or domiciled in a country that is the party to a double taxation treaty with Thailand, but such double taxation treaty does not exempt the foreign juristic person from withholding tax on the capital gain realized from the sale of securities in Thailand, the Offeree is required to fill in details of the acquisition cost of tendered securities in "Form for Declaration of Cost of Tendered Securities" for ordinary shares in Enclosure 7.4 for withholding tax purposes together with evidences that demonstrates such acquisition cost and payment of withholding tax.
